2. Scrap/Waste Paper - The PCB certificate is required.
3. THC charges - Rs 4,250/- for twenty feet and 6,450/- for forty feet plus applicable GST.
4. Labour charges- Rs. 100/- PMT
5. The loading charges of additional equipment will be applicable on SSR basis.
6. Quantities, Quality, sizes, measurements, numbers and weights wherever stated are approximate. However, the actual quantity in turn may turn out to be more or less than the estimated quantity. In the event of actual quantity turning out to be more than the estimated quantity the buyer has to lift the indicated quantity. In the event of actual quantity turning out to be less than the estimated quantity, the buyer shall not be entitled to claim any damages, loss of interest or compensation on this account. If case where the UOM is LOT, the material as offered has to be lifted by the buyer on AS IS WHERE IS BASIS and no excess/short lifting shall be taken into account.

Payment to MSTC:

- Buyers are instructed to make MSTC payment through e-payment mode ONLY. NO other mode of payment will be accepted.
- The sale is through e-tender cum e-auction method. In case of e-tender . interested buyers can submit their bid through e-tender only once. Buyers may however simultaneously register their participation in the auction through e-auction methodology.

In terms of the government directives (under section 48 of the customs act, 1962) associated container terminals limited is organizing an online e- tender cum-auction of unclaimed/un-cleared import cargo.

1. The contract shall be treated as having been entered into as soon as the digitally signed sale order/acceptance letter is issued by MSTC. The period of contract shall be of sixty days from the date of last delivery order by MSTC against full payment made by the party. The contract shall be deemed to be complete as soon as the area is cleared of the entire material allotted or on completion of the period of contract as mentioned above, whichever is earlier.
2. The rates must be offered on unit basis for each lot separately not part thereof I.E. In rupees per unit only. **Goods are sold on "AS IS WHERE IS" & "NO COMPLAINT BASIS"**. Quantities, qualities, sizes, measurements, number and weights whether displayed on the system, at the time of online e-auction sale or specified in the sale list are sold on the assumption that the bidders have inspected the same and know what they are buying.
