

**Notes:**

- a. GST would be applied at the prevailing rates on the above charges as applicable from time to time.
- b. Exporters / CHAs / Forwarders are requested to complete the documentations and plan for the vessel connections to avoid last minute rush. CFS would advise the gate cut off position from time to time.
- c. The CFS would be invoicing for the services before the gate pass generation. The dues are to be settled by way of Account Payee Cheque / Demand Draft / RTGS / NEFT/ POS machine. Customers are encouraged to open Pre-Deposit Accounts.
- d. CFS would not be liable to pay any charges levied by the Container Terminal.
- e. For shipments being received by Rail – Tariff would be decided based on the scope defined by the Customer and will be advised on a case to case basis.
- f. Any outstation Transportation charges shall be decided on case to case basis.
- g. Form 13's / Shipping Bill LEO for the Export Shipments are to be organised by the Exporters / CHAs
- h. Forwarders well in time to ensure that the containers do not wait outside the Container Terminal.
- i. VCT CFS would be implementing Safe Practices and requests the representatives of the Shippers / CHAs / Forwarders visiting the CFS to co-operate.
